Pretests for 2020 21

- All students should have a pretest
 - Rollover assessments from 2019-20
 - Same rules as always; within 150 days before the current year's enrollment date
 - A test given more than 30 days after the PY 2019-20 start day CAN be rolled over
 - If no 2019-20 assessment that can be rolled over, must administer a test in this PY
 - Preference: administer before student starts class
 - 2nd choice: administer within 30 days of start date
 - Assessments given >30 days after start date will count, but won't produce the highlight in eData

WIOA Indicators of Performance

- Measurable skill gains (MSG)
- Credential attainment
 - Secondary and postsecondary together in a single outcome
 - Secondary only if ALSO employed or in postsecondary education or training within a year of exit
- Employment
 - Employment in second quarter after exit
 - Median earnings in second quarter after exit
 - Employment in fourth quarter after exit

Measurable skill gains (MSG)

- All participants and all PoPs
 - Educational functioning level gain
 - Gain measured by pre- and posttesting
 - Exit program then entry into postsecondary education by the end of the program year
 - Earning Carnegie Units (PA doesn't use this.)
 - Obtaining a secondary credential by the end of the program year

Exit based indicators of performance

- Credential and employment outcomes
- Reported for exited participants only
- Reported for each PoP
 - Must report success for each PoP
- Collected for specific times after exit
- Not collected for WIOA-defined excluded participants
 - Exited adult ed due to incarceration lasting 90 days or more
 - Deceased

Agency performance C.100 and C.135

- Aligned with federal ones but not exactly the same
- C.100 AE and FL Performance Standards
 - Identifies targets for the program year
- C.135 Cohorts for the Primary Indicators of Performance
 - Defines the agency performance indicators used by the division to evaluate grantees
 - Defines federal cohorts

Agency performance indicators

- MSG (pre/posttesting only)
 - Grant specific targets
 - EFL gain target for each level except ABE Level 6
 - Table 4B target
- Employed 2nd quarter after exit
- Median wages in 2nd quarter after exit
- Earned a HSE credential
- Entered postsecondary education or training
